**TERMS & CONDITIONS FOR ENGAGEMENT OF PRIVATE AMIN/SURVEYOR ON
PURELY SHORT TERM CONTRACT BASIS**

1. Scope of Service :

The major scope of the work of the Private Amin/Surveyor are as follows.

To provide Assistance to the Project Director regarding the following aspect.

- (a) Timely issue of notification under section 3(A) and 3(D) of NH, Act, 1956 and valuation of structure of PROW.
- (b) Coordination with District competent Authority & official of other concerned department for land acquisition .
- (c) Collection of accurate data required for land acquisition.
- (d) Expeditious of compensation claim/declaration of award.
- (e) Mutation of acquired land in favour of Central Government, in record of right.
- (f) Any other activity including field work as demanded by Project Director time to time for completion of LA activity for the respective District for 4/6 lanning works of NH-6 under NHDP-V.

2. Duration of Engagement:

The engagement shall be for a period of six months and from the date of acceptance of the appointment letter. The contract can be terminated at any time without notice and without assigning any reason. In the case of termination, no compensation will be payable, No notice of termination will be necessary and continuation shall be sole at the discretion of NHAI.

Service rendered on contract with NHAI shall in no way give any right to claim regularization /absorption in the Organization .

3. Essential Qualification .

- (a) Passed Madhyamik/Secondary/10th Standard from recognized Board/ Institute/ University.
- (b) Passed Admr / Surveyor examination from recognized Board/ Institute/ University.
- (c) **Minimum Experience:** 2 (Two) years in Land Survey work, preferably in Howrah, East Medinipur & West Medinipur District.
- (d) **Terms & Conditions :**
 - (i) Personnel engaged are to report to/or work under Project Director, PIU-Kolkata.
 - (ii) Remuneration payable to such individual per month as NHAI HQ Policy matter- Technical (183/2015) no. 11041/2187/2007-Admn dated- 05.11.2015.
 - (iii) Personnel engaged are to assist Project Director in all matters pertaining to land acquisition.
 - (iv) Extension of period of engagement beyond six month will be considered on case to case basis as per direction on Project Director and approval of Competent Authority .
